- 三、本文件自 2016 年 10 月 29 日起执行。同时废止国际业务提示 016-009 号。请各销售单位及时打印本提示并摆放在柜台醒目位置,同时在销售时务必要告知旅客;海航官网须在网站醒目位置进行提示。
- 四、请各销售单位在销售海航国内/国际客票时,做好旅客解释工作,以免影响旅客正常乘机。

- 2. **Sales Notice:** In light of the recent incidents involving battery incidents with Samsung about its Galaxy Note 7 devices globally, it is strongly advised passengers not to turn on or charge these devices on the aircraft and not to stow them in any checked baggage.

3. The policy of notice of international business art.016-009 will be terminated when this policy takes effect. Please print this notification, place it strikingly on the counter and remind the passengers while selling the tickets. Meanwhile, the OTA channel should be noticed at the same time.
