ACCESS AT THE CLUB ASPIRE LOUNGE FOR LONDON TO MANILA FLIGHTS

We are pleased to advise that effective **01 August 2017**, PR passengers holding Economy class tickets (revenue and non-revenue) departing London to Manila may now avail access to the Club Aspire Lounge located at Terminal 3 London Heathrow Airport. A corresponding Lounge Access fee shall be assessed /collected at **GBP30** per passenger.

Guidelines:

1. Lounge access will only be available for London (LHR) to Manila (MNL) PR flights.
2. Lounge access can be purchased through London Airport Check-in counter ONLY. Selling and collection will be done at the PR counter.
3. The following are the types of tickets eligible for lounge access:
 - a. Revenue tickets on economy class
 - b. Non-revenue tickets regardless of cabin class such as Industry Discount (ID), Agent Discount (AD), Company Convenience (CC) and Award tickets (BP) booked on economy class.
4. Lounge access can be sold upon check-in at four (4) hours prior to the Estimated Time of Departure (ETD) of the flight.
5. Lounge access fees are non-refundable, non-rebookable and non-transferable.
6. Rate above is per person. Children (ages 2-11) will be charge with the same rate as adults. Infants (below 2 years of age) will be accepted for free. Both infants and children must be accompanied with one paying passenger.
7. Passengers may pay using cash or credit card upon check-in. An EMD will be issued to document receipt of payment and a copy will be provided to the passenger.
8. Eligible customers must present their boarding pass with the **LNGE** indicator upon entry to the lounge.
9. Rate is applicable for a one-time entry with a maximum of four (4) hours at the lounge.
10. Guests must read Swissport Terms and Conditions regarding the use of Airport Lounge Facilities. Swissport Terms and Conditions shall apply.
