Requirements:
Passengers must travel with their sports equipment or must present any the following documents upon check-in.


Divers
a. Diving Certification Card or C-Card
b. Temporary Diver's Card
c. For Students

- Student's record issued by the Diving Center and/or
- Course Fee (Official Receipt) and/or
- Confirmation of attendance

Check-in agent must input in VCR remarks I.D. number or Official Receipt Number if available.

## Golfers

a. Golf Club Membership card

Sports Equipment is limited to one golf bag containing golf clubs and one pair of golf shoes

## Bikers

Must travel with their bicycles.

Sports Equipment is limited to one suitable packed bicycle (Single seat touring or racing bicycle, non-motorized, provided that handle bars are fixed sideways and pedals are removed.


PAL reserves the right to refuse carriage of 40kgs FBA, if passenger fails to comply with the above requirements. Normal FBA shall apply and any excess will be assessed applicable excess baggage fee.
Sports equipment must be check-in at least 1 and a half hours before flight departure.
Bicycles however should be checked-in three hours before flight departure.
