## **CHECK BEFORE YOU FLY**



It is our shared responsibility to keep our passengers notified on any changes to their flight schedule.

Make it a habit to check your passengers' flight schedule in two easy ways:



Open the **Designated Queue (Q)** for Flight Schedule Changes. The affected segment is on KK status. Please update the KK segment to HK once the updated flight schedule has been relayed to passengers.



If the flight will depart within 48 hours, go to philippineairlines.com/#PALFlightStatus or click the Flight Status Tab in the PAL website.

If you receive Flight Notifications from PAL, please ensure to notify your passengers of their updated flight information. Passengers can also automatically receive Flight Notification e-mails from Philippine Airlines if you input their contact information in their PNR.

Concerned Stations are reminded to strictly follow the one hour closing time policy at the check-in counter to ensure that all passengers are not at the holding area in time for boarding and door closure within the standard 5-minute before ETD window.

On the other hand, the rest of the Domestic and International online stations not included in the above list remain to observe the 45 minutes check-in counter closure time before ETD.

## HANDLING GUIDELINES FOR MANILA TO KUWAIT TICKETS

Following the directive of the President of the Philippines, the Department of Labor & Employment has announced for the total ban of deployment of all Overseas Filipino Workers (OFW) in Kuwait.

In view of this, the following guidelines must be observed on tickets (regardless if with restricted/unrestricted fare rules) only of the OFWs and their dependents and with routing from Manila to Kuwait.

Rebooking shall be allowed without penalty, using the same RBD/BCC, provided the tickets are valid or within the ticket validity period.

However, for those expiring tickets, rebooking without additional fare may only be allowed if new flight date shall be within thirty (30) days from the original ticket validity. Otherwise, additional fare shall be assessed. Change fee shall be waived.

In cases when rebooking shall be made on a higher RBD/BCC, an additional fare shall be assessed / collected, and ticket must be reissued. Change fee/rebooking penalty shall be waived.

Passengers who opted to refund their tickets and/or EMD for ancillaries, shall be allowed. Waive refund penalty.

Electronic Miscellaneous Document (EMD) that are issued for ancillaries such as CESS, FESS and prepaid baggage may be rebooked to the passenger's new flight/flight date.

For tickets that will require reissuance or ticket exchange, annotate the Endorsement/Restriction field of the new ticket with – INVOL DUE KWI TRVL BAN.

## PAL'S ENHANCEMENT OF ITS SECURITY MEASURES FOR US-BOUND FLIGHTS

Effective February 15, 2018, Philippine Airlines is implementing enhanced security measures for its US-bound flights, specifically, from Manila to Los Angeles, San Francisco, Honolulu and Guam, as well as PAL flights from Vancouver to New York (JFK) by way of additional check-in procedures.

These measures are in compliance with the regulatory requirements of the US Department of Homeland Security for all flights operating from the 'last point of departure to the United States'.

PAL is advising passenger of US-bound flights to expect a slightly different check-in set-up and to allot extra time to arrive early at the airport, preferably 3-4 hours before flight departure.

The airline is also seeking the understanding and kind cooperation of passengers as it strives to find ways to offer the riding public with better, much safer and more efficient service.

Please be reminded that PAL is a Universal Air Travel Plan (UATP) merchant and therefore accepts this form of payment through BSP travel agents and PAL direct channels such as ticket offices, airport counters and Domestic Sales Agency (DSA). For BSP agents, charge approval shall be through the BSP Network with direct connection to UATP's ATCAN authorization system.

Prime issuance and reissuance of international tickets, ancillaries covered by electronic miscellaneous document (EMD), excess baggage transaction documented by miscellaneous sales receipt (MSR) may be charged to UATP.
