About issuing EMD 0B5 in GDS Travel Sky (1E)

Dear Colleagues,

Please be informed that from June 04, 2020 GDS TravelSky (1E) implemented the possibility of issuing EMD-A to pay for the services "Preliminary reservation of seats in the aircraft cabin" and "Rendering Service for Enhanced Comfort Seats Selection" on flights of Siberia Airlines, JSC.

The prices of services are published in GDS. The issuance is processed on EMD-A with 0B5 code.

• Preliminary reservation of seats in the aircraft cabin:

0B5 - PRE-RESERVED SEAT - service fee for the preliminary seats reservation

• Enhanced Comfort Seats Selection in the aircraft cabin:

0B5 - EXTRA SPACE SEAT - service fee for comfort seats selection

The seats reservation is processed in accordance with the requirements of GDS TravelSky.

The service fee payment and EMD issuance is proceeded only after the confirmation of requested service by the Carrier.

The services issuance is processed only with confirmed booking status.

Preliminary reservation of a seat and comfort seat selection in the aircraft cabin is made upon seat map request both at the moment of reservation creation and issuance of a ticket, and later, when the

ticket is already issued. If the seat map is not available in the reservation system, then a preliminary reservation of a seat and comfort seat selection is not possible.
