ENTRY REQUIREMENTS TO

THAILAND

The Thai authorities have introduced requirements for customers arriving in the country.

Please note that entry restrictions may be subject to change on short notice. You are responsible for ensuring that you are allowed entry into the country you are travelling from, to or are in transit through.

All non-Thai nationals must have a valid Thai visa or a re-entry permit. The following entry requirements apply:

Thai nationals

- You must hold Certificate of Entry issued by Thai Embassy or Consulate in your country of residence.
- You must hold a Fit to Fly Health Certificate issued in English at most 72 hours before departure from the first embarkation point.

You must hold an ASQ (Alternate state quarantine hotel)
 booking confirmation on arrival date for 14-day quarantine at you own expenses.

Spouses, parents or children of a national of Thailand

- You must hold Certificate of Entry issued by Thai Embassy or Consulate in your country of residence.
- You must hold a Fit to Fly Health Certificate issued in English at most 72 hours before departure from the first embarkation point.
- You must hold a medical certificate with a negative coronavirus RT-PCR test result in English issued at most 72 hours before departure from the first embarkation point.
- You must hold an insurance to cover medical expenses in Thailand.
- You must hold an ASQ (Alternate state quarantine hotel)
 booking confirmation on arrival date for 14-day quarantine at you own expenses.

Residents of Thailand

 You must hold Certificate of Entry issued by Thai Embassy or Consulate in your country of residence.

- You must hold a Fit to Fly Health Certificate issued in English at most 72 hours before departure from the first embarkation point.
- You must hold a medical certificate with a negative coronavirus RT-PCR test result in English issued at most 72 hours before departure from the first embarkation point.
- You must hold an insurance to cover medical expenses in Thailand.
- You must hold an ASQ (Alternate state quarantine hotel)
 booking confirmation on arrival date for 14-day quarantine at you own expenses.

Passengers with a visa issued by Thailand

- You must hold Certificate of Entry issued by Thai Embassy or Consulate in your country of residence.
- You must hold a Fit to Fly Health Certificate issued in English at most 72 hours before departure from the first embarkation point.
- You must hold a medical certificate with a negative coronavirus RT-PCR test result in English issued at most 72 hours before departure from the first embarkation point.

- You must hold an insurance to cover medical expenses in Thailand.
- You must hold an ASQ (Alternate state quarantine hotel) booking confirmation on arrival date for 14-day quarantine at you own expenses.

Students

- You must hold Certificate of Entry issued by Thai Embassy or Consulate in your country of residence.
- You must hold a Fit to Fly Health Certificate issued in English at most 72 hours before departure from the first embarkation point.
- You must hold a medical certificate with a negative coronavirus RT-PCR test result in English issued at most 72 hours before departure from the first embarkation point.
- You must hold an insurance to cover medical expenses in Thailand.
- You must hold an ASQ (Alternate state quarantine hotel)
 booking confirmation on arrival date for 14-day quarantine at you own expenses.

All customers listed above must complete a T8 health declaration form before arriving in Thailand and carry with

them a print-out of the completed form. The form is available via Thai embassy websites.

All non-Thai nationals must obtain medical insurance which will cover a minimum of USD 100,000 (or equivalent in other currencies) of medical costs incurred by the applicant in Thailand, including medical costs in the event that applicant contracts corona.

International-to-international or domestic connections are not allowed.

We scan temperature at the departure gate in Helsinki for all customers. It is good to know that we will deny boarding for customers not fulfilling the health requirements set by the Thai authorities and those showing symptoms of coronavirus.
