As of the new COVID-19 outbreak situation, it has spread rapidly in many provinces. Thai Smile Airways Company Limited would like to inform you the guidelines for helping passengers affected by the new epidemic situation by using this operation in place of all other previous issues as follows:

- 1. Passengers who hold a Thai Smile Airline ticket (Number 909-) 持有泰国微笑航空客票(票号 909 开头)的旅客。
- 2. Processing about tickets must be processed within 28 February 2021 only. 完成操作时间必须在 2021 年 2 月 28 日 (含) 以前。
- 3. Please notify the cancellation of the original flight no less than 4 hours before departure. 请务必在航班起飞前 4 小时以外取消并重新预定。
- 4. For passengers who issued a Thai Smile ticket on / before 21 December 2020 for travel on / after 22 December 2020 and on / before 28 February 2021 机票出票日期在 2020 年 12 月 21 日 (含)以前的,旅行日期在 2020 年 12 月 22 日 (含)以后至 2021 年 2 月 28 日 (含)以前的。
- 5. The ticket is a travel with Thai Smile on all Domestic routes in Thailand 所有使用泰国微笑航空公司在泰国境内的航线。
- 6. Change of travel date by proceed changes before the expiration of the ticket and / or proceed within 28 February 2021 as determined by which day will come first. With details as follows:

- If the journey is new within the validity of the original ticket It is the same route / or original RBD, use the same fare. Without fee.

- If the new journey is not within the validity of the original ticket, even if the journey is the same route / or original RBD, recalculation fare is required, any additional amount to be collected (If any). Without fee.

 Whether traveling within the original ticket validity or not traveling within the original ticket validity to recalculate the fare, any additional amount to be collected (If any).
 Without fee.

- 7. Refunding transaction shall be processed based on its attached fare rule, and / or condition.

- 8. The agent can proceed reissue the ticket according to the conditions above guidelines by

9. ** Passengers who wish will keep the balance of the ticket in the form of Travel Voucher (EMD) to be used for ticket issuance on the next trip. Passengers can keep the balance for use within 120 days from the date of issue of Travel Voucher (EMD). Passengers can submit their request through the website by themselves at http://member.thaismileair.com/customer service/refund and select another cause for request, specify Covid-19 or the agent can send the matter to the Sales and Distribution Department of Thai Smile Airways Co., Ltd. that takes care of the agent via email at 旅客如有需要,可将剩余票款以旅行代金券形式保存,以便下次旅行时购买客票使用。旅客可于旅行代金券签发之日起 120 天内使用该余额。旅客可以通过网站 http://member.thaismileair.com/customer service/refund 提交申请或选择另外一个理由申请,即指定 Covid-19,或代理人可以将此申请发邮件至负责代理的泰国微笑航空有限公司销售分销部: agency.sales@thaismileair.com
