Subject: Urgent Notice to Remind Passengers for Entering Japan

(Latest information as of 31MAR2021)

In line with Japan Quarantine Law, all passengers must provide a negative certificate of COVID-19 inspection that was conducted within 72 hours before departure when entering Japan on/after 19MAR2021, airlines are obliged to deny passengers boarding flights for those fail to provide valid inspection certificates at departure country before boarding.

Japan Airlines wishes to remind agency of the requirement to advise passengers' advance preparation of negative test certificate of COVID-19 inspection when entering Japan, and please inform to passengers who have booked flights to Japan take note the following points when obtaining certificate of COVID-19 inspection.

## 1. Sample Collection Method

Valid sampling method (either of the followings is valid):

- Nasopharyngeal Swab
- Saliva

<Note> It is invalid for "Oral swab, Throat swab", " Nasal swab, Nose swab" and "The combination of nose and throat".

## 2. COVID-19 Inspection Method

The following is valid method of COVID-19 inspection as of 31MAR2021 for reference:

- Real time RT-PCR (Real time reverse transcription PCR)
- LAMP (Loop-mediated Isothermal Amplification)
- TMA (Transcription Mediated Amplification)
- TRC (Transcription Reverse-transcription Concerted reaction)
- Smart Amp (Smart Amplification process)
- NEAR (Nicking Enzyme Amplification Reaction)
- Next Generation Sequence
- Quantitative Antigen Test (CLEIA) \*NOT a Qualitative Antigen Test

## 3. Date and Time of Specimen Collection

It is required to indicate the following Date and Time on the inspection certificate.

- The date of issuance of test certificate
- The date and time of specimen collection (Within 72 hours before departure)
