### **Residual Flight Credits**

#### **残值机票抵用金**

15. Residual Flight Credits is retained in the form of an EMD (RSVR EMD: RFIC='D', RFISC='996').

16. Residual Flight Credits are non-refundable unless otherwise permitted by this Policy.

17. Residual Flight Credits are non-combinable and non-transferrable.

18. At the point of rebooking of the new flight itinerary, the Bonus Flight Credit (if applicable) shall first be applied to the total cost of the new flight itinerary.

在改期预订新行程时, 应首先将额外机票抵用金(如适用)应用于新行程的总费用。

19. Where the Flight Credits retained is sufficient to cover the cost of the new flight itinerary (or the balance cost of the new flight itinerary if the Bonus Flight Credit is applicable), the entire cost of the new flight itinerary (or the entire balance cost of the new flight itinerary, as the case may be) shall be deducted against the Flight Credits. ## B. APPLICATION OF FLIGHT CREDITS, BONUS FLIGHT CREDITS AND RESIDUAL FLIGHT CREDITS

## 机票抵用金、额外机票抵用金和残值机票抵用金的应用

During Rebooking 改期操作:

1. Create a new booking with the passenger's preferred itinerary, for travel completion on/before 30 June 2022.  
使用乘客的首选行程创建新的预订, 此预定需在 2022 年 6 月 30 日及之前完成旅行。
  2. Reissue the open ticket to the new itinerary, with the applicable Bonus Credits deducted from the fare.  
根据新行程, 将留改机票重新出票, 并从票价中扣除适用的额外机票抵用金。
  3. To determine whether to collect ADC or issue residual value EMD for residual balance, compare the new itinerary's fare against the original itinerary's fare plus bonus credit (example below is SGD 100).

**C. FREQUENTLY ASKED QUESTIONS**

**常见问题**

**General Policy 一般政策**

**1. If the Covid-19 situation persists, will SIA consider extending the validity of the Flight Credits?**

如果 Covid-19 的情况持续存在, 新航是否会考虑延长机票抵用金的有效期?

We will continue to review and update our Travel Waiver Policy based on the development of the Covid-19 situation, and keep you updated.

我们将根据 Covid-19 的发展情况, 继续审查和更新我们的旅行豁免政策, 并随时通报最新情况。

**2. What are Flight Credits?**

什么是机票抵用金?

To give our customers a peace of mind during this uncertain times and greater flexibility in their rebooking options in the future, Singapore Airlines introduced Flight Credits.

为了让我们的客户在这个不确定的时期对于选择新航飞行更加安心, 并允许他们在未来的改期预定等选择上有更大的灵活性, 新加坡航空公司特别推出了此机票抵用金。

Customers holding Eligible Tickets can cancel their existing flight bookings and retain the full value of the unused fare and taxes ('value') portion of their tickets as Flight Credits. Once they have decided on their new travel plans, customers may use the Flight Credits to rebook their new flight itineraries, which only has to be completed by 30 June 2022. In addition, they will get a one-time Bonus Flight Credit upon rebooking.

持有合格机票的客户可以取消其现有的航班预订, 并保留其机票中未使用的票价和税费 ( “价值” ) 部分的全部价值作为机票抵用金。一旦确定了新的旅行计划, 客户可以使用机票抵用金重新预订新的航班行程, 并在 **2022 年 6 月 30 日** 前完成飞行。此外, 他们将获得一次性的额外机票抵用金, 用于新的预订。

**3. What are Bonus Flight Credits?**

什么是额外机票抵用金?

Bonus Flight Credits are awarded to passengers who utilize their Flight Credits to rebook. The Bonus Flight Credits are offered at the point of rebooking, in the form of a discount off the rebooked itinerary's fare.

额外机票抵用金是奖励给那些利用其机票抵用金重新订票的乘客。额外机票抵用金是在改期预订时提供的, 以新的行程票价的抵扣方式来提供。

**4. I have a ticket which meets the eligibility criteria of the Policy, but has expired at point of reissuance. What can I do?**

我有一张符合资格的机票, 但已过期。我能做什么?

In the event an eligible ticket has expired, travel agents may proceed to manually reissue ticket as long as rebooked travel is completed by 30 June 2022. The ticket will also be eligible for Bonus Flight Credits, subject to the terms and conditions of this Policy.

如果符合条件的票已过期, 代理人/旅行社可继续手动补订并重开机票, 只要重新预订的行程在 **2022 年 6 月 30 日** 前完成。同时, 根据本政策的条款, 该机票也有资格获得额外机票抵用金。

## **Eligibility 资格**

**5. Are tickets involving codeshare partners and Scoot eligible for Flight Credits and Bonus Flight Credits?**

涉及代码共享合作伙伴和 Scoot 的机票是否有资格获得机票抵用金和额外机票抵用金?

Yes, as long as tickets are issued on 618.

是的, 只要是 618 的票本。

**6. Are partially unused tickets eligible for Flight Credits and Bonus Flight Credits?**

部分未使用的机票是否有资格获得机票抵用金和额外的机票抵用金?

Partially Unused Tickets are eligible for Flight Credits to support reissuance of the ticket with waiver of rebooking fees. Partially Unused Tickets are not eligible for Bonus Flight Credits.

部分未使用的机票也有资格获得机票抵用金, 以支持机票的重新预定, 并免除改期手续费。但部分未使用的机票不能享受额外机票抵用金。

**7. Are one-way tickets eligible for Flight Credits and Bonus Flight Credits?**

单程机票是否有资格获得机票抵用金和额外的机票抵用金?

Yes. For Bonus Flight Credits, each ticket is eligible for the full quantum of the Bonus Flight Credits based on the cabin class of the highest RBD in the ticket.

是的, 可以。对于额外机票抵用金, 每张机票都有资格根据机票中最高订票舱等的客舱等级获得全额的额外机票抵用金。

**8. Is my child / infant's ticket eligible for Bonus Flight Credits?**

我的儿童/婴儿机票是否有资格获得额外机票抵用金?

Yes, if the full adult fare is charged for the ticket.

是的, 如果是成人票价的话 (儿童/婴儿折扣票价不可以)。

If a child/infant discount is applied to the Eligible Ticket, the ticket is not eligible for Bonus Flight Credits. However, the child/infant ticket value is still eligible for use as Flight Credits.

如果是儿童/婴儿折扣的机票, 则该机票不符合额外机票抵用金的条件。但是, 儿童/婴儿机票价值仍有资格用作机票抵用金。

**9. How can a passenger use his Flight Credits from the ancillaries purchased with Singapore Airlines (i.e. seat purchases or additional baggage allowance)?**

乘客如何使用从新加坡航空公司购买的辅营产品(即座位购买或额外行李额)中获得的机票抵用金?

Amounts paid for ancillaries are not eligible for Flight Credits. However, they will be proactively refunded upon conversion of ticket's value into Flight Credits (i.e. open ticket without associated PNR) or refund.

**10. Are passengers impacted by flight cancellations due to Covid-19 eligible for the benefits under this Policy?**

Yes, passengers who have been impacted by flight cancellations due to Covid-19 are eligible, even if the ticket issuance date and/or travel dates do not meet the criteria of this Policy.

Where passengers are impacted by flight cancellations, their tickets are automatically converted to an open ticket, with the unused value available for use as Flight Credits. They are further eligible for Bonus Flight Credits and the waiver of rebooking fees.

Should passengers decide not to travel, they can also opt for a full refund, with waiver of cancellation fees. This applies to non-refundable tickets too.

#### **12. Can Flight Credits be transferred?**

In the event a passenger is unable to travel by 30 June 2022, his Flight Credits cannot be transferred to another passenger. Please process a refund of the open ticket, subject to the terms and conditions of this Policy or the ticket's fare conditions.

#### **13. Can Flight Credits be combined?**

**机票抵用金可以合并使用吗?**

No. Flight Credits from separate Eligible Tickets cannot be combined.

#### **14. Can the Bonus Flight Credits be cashed out?**

No. Bonus Flight Credits may not be exchanged for cash at all, during issuance, reissuance or refund.

#### **15. What is RSVR EMD?**

RSVR EMD is an EMD for Residual Value with RFIC = 'D' and RFISC = '996'.

RSVR EMD 是残值 EMD, 包含 RFIC='D', RFISC='996'.

#### **16. How do I issue the RSVR EMD?**

**如何开具残值 RSVR EMD?**

As steps to issue a RSVR EMD vary by GDS-es, kindly contact your GDS for assistance on entries required.

**17. How can the passenger make use of the residual balance?**

Travel Agents may approach our Sales Operations unit for assistance with the booking of a 2<sup>nd</sup> itinerary, and issuance of a new ticket against the residual value EMD.

**18. What if there is still a residual balance after using part of its value for another ticket purchase?**

Any residual balance from the RSVR EMD will be forfeited. This is effected by inserting the unused portion as a penalty fee during the refund of the RSVR EMD.

**19. Can the RSVR EMD be refunded?**

The RSVR EMD may be refunded subject to the terms & conditions of this Policy. Otherwise, it is strictly non-refundable.

**20. What is the validity of the issued RSVR EMD?**

**开具的残值 RSVR EMD 的有效期?**

The RSVR EMD must be 'utilized' by the "rebooked travel by date" of this Policy. RSVR EMDs unutilized by then will expire and value will be forfeited.

残值 RSVR EMD 必须按照此政策“按要求日期重新预订的旅行”规则来使用。届时未使用的残值 RSVR EMD 将过期并被没收。

**21. Is the RSVR EMD transferrable?**

**残值 RSVR EMD 是否可转让?**

No. 不能。

**22. Are Eligible Tickets, which have already been rebooked with penalty fees, eligible for reimbursement of penalty fees?**

在改期订票时已经收取相关手续费的符合资格机票, 是否可以重新拿回相关手续费?

No. 不可以。

**23. Are Eligible Tickets, which have already been rebooked, eligible for waiver of rebooking fees?**

**已改期的符合资格的机票, 在后续预订中, 是否可以被免收改期手续费?**

Reissued tickets which still meet the eligibility of this Policy are eligible for waiver of rebooking fees.

可以; 已重新出票的机票如仍符合本政策要求, 仍可获豁免手续费。

Otherwise, any subsequent change of these reissued tickets are subject to the fare conditions of the reissued tickets.

否则, 这些机票在任何后续的变更中均需要以重新预定的票价条件为准。

**24. Are Eligible Tickets which have already been rebooked eligible for Bonus Flight Credits?**

已重新预订的符合资格机票是否有资格获得额外机票抵用金?

Reissued tickets which still meet the eligibility of this Policy are eligible for conversion to Flight Credits and be awarded with Bonus Flight Credits.

重新预定的机票如果仍符合本政策规定,则有资格转换为机票抵用金,并可获得额外机票抵用金。

However, Eligible Tickets which have been reissued to outside this Policy (i.e. for travel in June 2021) are not eligible for Bonus Flight Credits.

**Refunds 退款**

**25. Are all tickets eligible for full refund?**

Yes, all Eligible Tickets under this policy are eligible for full refund, with waiver of cancellation fees.

**26. Are non-refundable tickets eligible for full refund?**

Yes, as long as the ticket meets the eligibility criteria of this Policy.

**27. Are Eligible Tickets which have already been refunded with penalty fees eligible for reimbursement of penalty fees?**

**28. Are Eligible Tickets, which have already been rebooked, eligible for waiver of cancellation fees?**

已被改期后的符合资格的机票, 是否可以免收退票费?

Reissued tickets which still meet the eligibility of this Policy are eligible for waiver of cancellation fees.
