Subject: Reminder notice of negative certificate requirement for travelling to The United States

Please be reminded the negative certificate requirement for travelling to U.S. as below:

(1) All Airline Passengers Arriving into U.S.

It is required to have a negative certificate with **a sample taken within 1 day before departure, regardless of the vaccination status or citizenship** before boarding a flight to the U.S. from a foreign country to meet the requirements.

Example: JL736/24DEC2021/HKGNRT, Dep. Time: 03:00 a.m. Arr. Time: 08:05 a.m.
JL8012/24DEC2021/NRTDFW, Dep. Time: 10:55 a.m. Arr. Time: 07:15 a.m.
Test must be **conducted no earlier** than 23DEC2021.

(2) Transit one/more connecting flight to U.S.

Your test can be taken **within 1 day before the departure of the first flight.**

Example: CX381/23DEC2021/PVGHKG, Dep. Time: 07:00 p.m. Arr. Time: 09:55 p.m.
JL736/24DEC2021/HKGNRT, Dep. Time: 03:00 a.m. Arr. Time: 08:05 a.m.
JL8012/24DEC2021/NRTDFW, Dep. Time: 10:55 a.m. Arr. Time: 07:15 a.m.
Test must be **conducted no earlier** than 22DEC2021

(3) Exemption

- Children under 2 years of age
- U.S. federal law enforcement personnel
- U.S. military personnel
- Those with humanitarian exemptions approved by CDC (must present official CDC letter)

(4) Recovered from COVID-19

Passenger travel with documentation of recovery from COVID-19 (i.e., your positive COVID-19 viral test result on a sample taken no more than 90 days before the flight's departure from a foreign country and a letter from a licensed healthcare provider or a public health official stating that you were cleared to travel).

(5) Others

Obligation for a non-US nationals or citizens to have a vaccination certificate is still effective.
US nationals and permanent residents are not required to have a vaccination certificate.
