SERVICES UPDATE April 1 – June 30

With the lifting of flights and arrivals ban from the 9 countries including Canada effective April 1, Air Canada customers who wish to fly back to Hong Kong from April 1 – April 22 may connect in Seoul or Tokyo and continue their journeys to Hong Kong with our airline partners. Entry requirements for customers travelling to Canada

Effective April 1, [fully vaccinated](#) customers no longer need to show proof of a pre-departure COVID-19 test result for air travel to Canada. Fully vaccinated customers may still be selected for random testing on arrival but are not required to quarantine while awaiting their test result. All customers (regardless of how long you were away from Canada) will continue to be required to submit their mandatory information on the [ArriveCAN](#) app or website.

Connecting to the rest of Canada with Air Canada has become easier

Effective March 2, passengers travelling on Air Canada flights from Hong Kong **no longer need to retrieve their bags** during transit at Vancouver or Toronto if they have an onward domestic connection within Canada.

Customers must meet all the following eligibility requirements:

1. Traveling on AC8 from Hong Kong to Vancouver, or on AC16 from Hong Kong to Toronto with an onward domestic connection within Canada on Air Canada flights.
2. Have a piece of checked baggage that is tagged to the final destination.
3. Are not travelling with a PETC (Pet in Cabin) **, AVIH (Pets in Cargo Hold) ** or WEAP (Weapon) ** Service animals are not considered PETC or AVIH and customers travelling with service animals are eligible when all other requirements are met.
