**Subject: Extension of Free excess baggage campaign & Free onboard Wi-Fi service for Hong Kong to North America**

Please be informed that “Free Excess baggage campaign” & “Free onboard Wi-Fi service” as follows.

**(1) Promotion period:** (Based on 1st JL operating international flight date)

Sales period : Until 25 April, 2022

Travel period: On/before 29 April, 2022

**(2) Applicable Route/Flight and Ticket:**

- Passengers who booked and purchased JAL Roundtrip or One-Way tickets originating from Hong Kong to North America on eligible JAL flights during promotion period.
- Flights from HKG to Japan and Japan to North America must be operated by JAL.
- If itinerary (HK>JP>N.A) includes codeshare flights operated by other airlines, campaign benefits will not be applicable.
- Return segment is not eligible for free extra baggage allowance.
- JAL international tickets starting with the 131 airline code.

**(3) Applicable Class:** All ticket fare type including Child, Infant and Award tickets.

**(4) Special Offer:**

Free Excess baggage campaign

In addition to the normal free checked baggage allowance, one free excess baggage will be entitled.

\*Total baggage allowance for First class and Business class: 3 + 1 Piece.

\*Total baggage allowance for Premium economy and Economy class: 2 + 1 Piece.

This service can be used together with JAL Global Club, JMB Service Status and Oneworld Elite Status Member benefits.

Free onboard Wi-Fi service

Eligible passengers will receive a 24hrs complimentary Wi-Fi code which able to access the internet while onboard JAL operated international flights.
